**MESSAGE:**

There are four different documents. First document is the Petition for Disclosure of Records to the Court (3 pages); the second document is an order for OKDHS to produce records to the court for the court's review (3 pages). The third document is the order issued after judicial review of the records that authorizes disclosure under a protective order (3 pages). The fourth document is an order for witness appearance (2 pages).

Prepare the Petition and Order to produce records to the court and present to court for signature. Mail or fax the Petition and Order for Records to OKDHS. For appearance of OKDHS witnesses, serve the individual witness. **See contact information sheet on where to route petitions and court orders.**

At the records hearing, the court may believe that the records should be released to the petitioning party. If so, provide the court with the order authorizing release of confidential information or records (**after judicial review**) under a protective order.

If you will not need an OKDHS employee to testify at the initial records hearing, please delete that paragraph from the order. You can always ask that the court order testimony from OKDHS witnesses if the court determines disclosure of the records or confidential information should occur.

If names of OKDHS witnesses are discovered after the records have been released and OKDHS testimony is needed, please use the Order for Appearance of Witness form also enclosed to secure attendance of OKDHS witnesses.

Feel free to use these forms and modify as needed for your particular circumstances.



have information pertaining to the aforementioned agency records which are relevant to the issues of this proceeding and which will inform and assist the court in reaching a decision in this matter.

4. Pursuant to 10 O.S. §7005-1.2, a court order directing production of the agency records for judicial review of the records and a court order authorizing disclosure of the records is necessary for this party to have access to the agency records and any information contained therein.

5. A compelling reason exists for the inspection, release or disclosure of such records and the testimony of \_\_\_\_\_ and such disclosure is necessary for the protection of a legitimate private or public interest for the following reasons: **[State the reason the information is needed and the public or private interest being protected by the disclosure, e.g., child custody matter.]**

**ORDER AUTHORIZING RELEASE AND DISCLOSURE OF RECORDS,  
ORDER FOR TESTIMONY OF WITNESSES AND PROTECTIVE ORDER**

**NOW** on this \_\_\_\_\_ day of \_\_\_\_\_, 20 \_\_\_\_\_, this matter comes on for the review of the agency records and the information contained therein maintained by the Oklahoma Department of Human Services ["OKDHS"] pertaining to :

The Court, being fully advised in the premises, **FINDS:**

1. That in accordance with 10 O.S. §7005-1.2, the Court has reviewed the records provided by OKDHS pursuant to this Court's order. With due regard for the confidentiality of the records and the privacy of the persons identified in the records, the Court finds that a compelling reason exists and it is necessary for the protection of a legitimate public and private interest to authorize the inspection, release and/or disclosure of the records pertaining to those persons named above to the party requesting said records.

2. That certain employees of OKDHS as set forth below have information pertaining to the subjects of the confidential records which is relevant to the issues of this proceeding and which will inform the Court and assist in reaching a decision in this matter.

**IT IS THEREFORE ORDERED, ADJUDGED AND DECREED** by the Court that the agency records [**or hereinafter described records**] pertaining to those persons named above shall be released and disclosed to the requesting party, and/or that the following employees of OKDHS, to-wit: \_\_\_\_\_, shall be required and are directed to testify at trial about the information contained in

said agency records. The production of OKDHS records and/or testimony of an OKDHS employee or employees, shall be conditioned on the following terms or restrictions:

- a. The agency records being released and disclosed are confidential records pursuant to 10 O.S. §7005-1.2 and shall not be open to the general public or inspected or their contents disclosed other than as set forth in this Order.
- b. Disclosure of the agency records identified herein and/or testimony relating to confidential information is limited to the parties to this action, their attorneys, and those persons employed or acting on behalf of the parties and their attorneys whose aid is necessary in the prosecution or defense of this case.
- c. The confidential agency records and documents hereby released and any confidential testimony given herein shall not be used for any purpose other than the preparation and conduct of these proceedings.
- d. No documents, pleadings or records which contain confidential information shall be filed except under seal with the legend "THIS DOCUMENT CONTAINS CONFIDENTIAL INFORMATION AND IS SUBJECT TO A PROTECTIVE ORDER OF THE COURT".
- e. Information that would identify the person or persons who made a report of child abuse or neglect has been deleted and shall remain confidential unless a specific court order is obtained for the for the release of said information.
- f. The release by counsel or any other person for any reason of any identifiers such as social security or tax identification (ID) numbers that may be contained in OKDHS records and which belong to any person or entity is **strictly prohibited**.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** by the Court that the agency records and their contents and any testimony pertaining to those records shall remain confidential and the use of the records and information contained therein, shall be limited to the purposes set forth herein for which disclosure is authorized.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** by the Court that the testimony being offered regarding the confidential information in the agency records is also confidential so the proceedings shall be closed to the public and only the parties and their counsel shall be allowed to hear such testimony.
