



# Free \$ for training in 2009 – 10 From Oklahoma Child Care Services

Child care centers licensed for up to 50

– Your facility has 8 conference voucher credits

\*2 and 3 Star Child Care Centers licensed for up to 50

– Your facility has 16 conference voucher credits

Child care centers licensed for 51-99

– Your facility has 10 conference voucher credits

\*2 and 3 Star Child Care Centers licensed for 51-99

– Your facility has 20 conference voucher credits

Child care centers licensed for over 100

– Your facility has 12 conference voucher credits

\*2 and 3 Star Child Care Centers licensed for more than 100

– Your facility has 24 conference voucher credits

Each person may use one conference voucher credit per conference (*list of eligible conferences on back of this page*).

### *How it works.*

When you receive the registration materials from a conference, simply write your license number (K8#) on the registration form. When you pay for the conference, simply subtract \$25 from the registration fee. For example, if the registration fee is \$50, subtract \$25 and send a check for \$25. If the fee is \$35, send \$10. Be sure to sign in at the conference and tell them your license number (K8#).

### *The fine print*

*Voucher credits are non-refundable.* If you register for the conference using a conference voucher credit and do not attend, you will not get the credit back. However, if a staff person is unable to attend once they have registered, a substitute staff person can attend in the original person's place.

*\*To receive doubled vouchers, you must be a 2 or 3 star facility as of July 1, 2009.*
