



# Free \$ for training in 2011-12 From Oklahoma Child Care Services

- ★ Family child care homes licensed for up to 7  
– Your home has 2 conference voucher credits.
- ★ \*2 and 3 star homes licensed for up to 7  
– Your home has 4 conference voucher credits.
- ★ Large family child care homes licensed for 12  
– Your home has 4 conference voucher credits.
- ★ \*2 and 3 star large homes licensed for 12  
– Your home has 8 conference voucher credits.

Each person may use one conference voucher credit per conference (list of eligible conferences on back of this page).

### How it works.

When you receive the registration materials from a conference, simply write your license number (K8#) on the registration form. When you pay for the conference, simply subtract \$25 from the registration fee. For example, if the registration fee is \$50, subtract \$25 and send a check for \$25. If the fee is \$35, send \$10. Be sure to sign in at the conference and tell them your license number (K8#).

### The fine print

Voucher credits are non-refundable. If you register for the conference using a conference voucher credit and do not attend, you will not get the credit back. However, if a staff person is unable to attend once they have registered, a substitute staff person can attend in the original person's place.

*\*To receive doubled vouchers, you must be a 2 or 3 star facility as of July 1, 2011.*
